

## PRIVACY POLICY

### **Introduction**

This privacy policy applies to V-Veil-UP PRODUCTION SRL and any of its affiliates which control and make use of information of a visitor of this Site (“Visitor”) collected via this Site. If the Visitor chooses to register or submit information to this Site, the Visitor agrees to the use of such data in accordance with this privacy policy.

V-Veil-Up PRODUCTION SRL reserves the right to modify or amend this privacy policy at any time and for any reason. The revised privacy policy shall apply to the use of the Site from the date of the publication of the revised privacy policy on the Site. Each Visitor must check this privacy policy regularly to ensure to be familiar with the latest version.

### **Collection of information**

The Visitor does not have to submit any personal information in order to use the Site. The Site collects only personally identifiable information that is specifically and voluntarily provided by Visitors. Such information may consist of, but is not limited to, Visitors’ name, email address, telephone number, country and profile.

V-Veil-Up PRODUCTION SRL does not usually seek sensitive information (e.g., data relating to race or ethnic origin, religious beliefs, criminal record, physical or mental health or sexual orientation) from Visitors. V-Veil-Up PRODUCTION SRL shall, where necessary, obtain Visitors’ explicit consent to collect and use such information.

### **Collection and use of personal information**

Personal information is used only for limited purposes. For example, when the Visitor registers with the Site to gain access to specific content or request future communications about V-Veil-Up PRODUCTION SRL, V-Veil-Up PRODUCTION SRL may use the information submitted by Visitor to create a personal profile to customize V-Veil-Up PRODUCTION SRL’ response to further requests or inquiries.

V-Veil-Up PRODUCTION SRL may also use the information to personalize Visitors Site experience. When the Visitor chooses to register online for a V-Veil-Up PRODUCTION SRL-hosted event V-Veil-Up PRODUCTION SRL will use the information submitted by Visitor to respond to the Visitor. In addition, V-Veil-Up PRODUCTION SRL may, where necessary, use Visitors information for various Site-related tasks.

V-Veil-Up PRODUCTION SRL will ensure that our marketing activities comply with applicable law, and implement procedures to obtain necessary consents before sending the Visitor email containing information about V-Veil-Up PRODUCTION SRL offerings. You may at any time request that V-Veil-Up PRODUCTION SRL discontinues sending the Visitor such materials.

### **Disclosure of information to third parties**

Although V-Veil-Up PRODUCTION SRL may provide Visitors’ information to service providers that handle information on our behalf, V-Veil-Up PRODUCTION SRL will usually not share the information with third parties for secondary or unrelated purposes unless otherwise disclosed at the point of collection.

Where appropriate, personal information may be disclosed to law enforcement, regulatory or other government agencies, or third parties where necessary or desirable to comply with legal or regulatory obligations or requests or for the purposes identified above.

### **Access to information**

V-Veil-Up PRODUCTION SRL provides reasonable access to Visitors who wish to review the personal information retained when they register with our Site and correct any inaccuracies it may contain. Visitors who choose to register may access their Visitor profile, correct and update their details, or unsubscribe at any time. Visitors who have any problem accessing their profiles or would like to request a copy of their personal information should contact V-Veil-Up PRODUCTION SRL using the contact details below. In all cases V-Veil-Up PRODUCTION SRL will treat requests to access information or change information in accordance with applicable legal requirements.

### **Information security**

### **Children's privacy protection**
